 - Decided to go with 4 smaller teams, skills based rosters
 - Had slated REC 1,3,4 teams
 - Now, with larger group, slated to REC 1,2,3,3
- Board decision: must have two skilled teams, two balanced teams

- Action item Peter to ask for volunteers to move down. B team is now skilled vs. balanced before, in REC 2.
