BU10:

- 5 teams, a few drops.
- 9/team all signed up, roster size 11,9,9,9,10.
- 1 player moved up.
- Jeremy is coaching currently, assistant is Sean Long Potential for Logan Anderson's dad and Logan Smith's dad to assist.
- Jeremy is coaching BU10, GU12 & BU12. Concurrent back to back games pose a problem. He has to leave before games end to get to next games.
- BU10D try to find a coach to help Jeremy.
- Rika will look at multi-team schedule to see Jeremy's conflict potential.
- Jeremy will stay as head coach of GU12C and BU12B.
- Coaches will remain same as Fall:
 - BU10A - Hendricks head, Jorgensen & Wilkey assistants
 - BU10B - Russo head, Milliken & Pelak assistants
 - BU10C - Allard head, Heinis & Scheonberg assistants
 - BU10D - Dalmer head, Long assistant
 - BU10E - Beckett head, Castro assistant

BU12A:

- 2 players dropped, 2 added. No head coach selected.
- Is Fernando Catalina a potential coach for the A team? Tom will reach out to him.
- Potential Challenger coach – do we charge for this?

BU12B - NCup:

- One player is recommended to be moved down by Jeremy, but since no official complaints have been made, this player can not be moved down.
- Allyson will call Leominster about school choice player to place appropriately.
- Jeremy is remaining as head coach.
- Alton, Rika, Dan as potential assistant coaches.

BU12C:

- Bill McNamara as head coach, Peter von Conta as assistant coach – need to add second assistant.
- Roster size is 15, but in Fall average game attendance was 10.
- For second assistant coach, Sean Burns or another potential is Trabulsi.
- Rika will contact Bill to confer on assistant.

GU12 - Karen:

- Good shape – 3 teams. All players returned on A & B except 1.
- A has 12, now has 11. B has 11 and C has 11.
- 2 new girls signed up and put on C team.
- No reported issues.
- Coaches will remain same as Fall:
 - GU12A - Reiter head, Barton & Mara assistants
 - GU12B - Franklin head, Gomez & LEcuyer assistants
 - GU12C - Dalmer head, Wig & Deng assistants

GU14 - Karen:

- Now at 24 – sent out emails and called to recruit, now up to 28 but 4 not paid pending team decision.
- Karen asked if a player can play games only. Board policy is can be rostered and play 3 games.
- Parent Manager can be Stu Sklar for B and Marissa Steel for A.
- Motion to have second GU14 team seconded and passed.
- Will not submit to Chuck until 4 players pay.
- Girls try-outs 17th & 23rd.
- No keeper tryouts for GU14.
